THE DELTA DENTAL MOBILE PROGRAM IS A STATEWIDE PROGRAM TO PROVIDE RESTORATIVE AND PREVENTIVE DENTAL CARE TO UNDERSERVED CHILDREN ACROSS SOUTH DAKOTA. FOR THE YEAR ENDED DECEMBER 31, 2021, A TOTAL OF 3,022 CHILDREN WERE PROVIDED ORAL HEALTH CARE. OF THE 3,022 CHILDREN SERVICED, 1,466 WERE MEMBERS OF MEDICAID, 1,238 HAD NO DENTAL INSURANCE, AND 318 CHILDREN HAD PRIVATE DENTAL INSURANCE. THE TWO TRUCKS PROVIDED 2,733 FLUORIDE VARNISHES, 2,382 CLEANINGS, 2,351 ORAL HEALTH INSTRUCTIONS, 13,530 SEALANTS AND ALL SERVICES PROVIDED ON THE TRUCKS HAD A VALUE OF CARE OF \$2,753,267 FOR WHICH THE DELTA DENTAL FOUNDATION ONLY RECEIVED \$647,809 IN COMPENSATING REVENUE FOR THE ABOVE SERVICES.

THREE GROUPS WERE TARGETED - CHILDREN UNDER NINE YEARS OLD, PREGNANT WOMEN AND MOTHERS OF YOUNG CHILDREN, AND PEOPLE WITH DIABETES. THE PROGRAM SEEKS TO INCREASE PREVENTIVE DENTAL CARE INCLUDING CLEANINGS, DENTAL SEALANTS AND FLUORIDE VARNISHES, AND EDUCATE COMMUNITIES ABOUT ORAL HEALTH AND ITS RELATIONSHIP TO OVERALL HEALTH. THE CMS GRANT ENDED 06/30/2015, BUT THE FOUNDATION FOUND VALUE WITH THE PROGRAM AND DECIDED TO EXTEND THE SERVICES WITHOUT GRANT MONEY FOR CHILDREN THROUGH THE 8TH GRADE. THE COVID-19 PANDEMIC NEGATIVELY IMPACTED THE NUMBER OF SERVICES WE WERE ABLE TO PERFORM DURING THE YEAR. IN 2021, 1,645 PATIENTS WERE SEEN. THERE WERE 1,738 FLUORIDE VARNISHES APPLIED, 1,656 CLEANINGS PROVIDED,
