OF THE 2,724 CHILDREN SERVED BY THE PROGRAM IN 2023, 1,227 HAD MEDICAID INSURANCE, 1,209 HAD NO DENTAL INSURANCE, AND 288 HAD PRIVATE INSURANCE. THE VALUE OF CARE PROVIDED WAS \$2,413,790 FOR WHICH THE DELTA DENTAL OF SOUTH DAKOTA FOUNDATION RECEIVED \$716,970 IN SERVICE REVENUE AND \$225,480 IN SITE PARTNER REVENUE.
