THE DELTA DENTAL MOBILE PROGRAM IS A STATEWIDE PROGRAM TO PROVIDE RESTORATIVE AND PREVENTIVE DENTAL CARE TO UNDERSERVED CHILDREN ACROSS, SOUTH DAKOTA. FOR THE YEAR ENDED DECEMBER 31, 2019, A TOTAL OF 3,275 CHILDREN WERE PROVIDED ORAL HEALTH CARE. OF THE 3,275 CHILDREN SERVICED, 1,603 WERE MEMBERS OF MEDICAID, 1,352 HAD NO DENTAL INSURANCE, AND 320 CHILDREN HAD PRIVATE DENTAL INSURANCE. THE TWO TRUCKS PROVIDED 2,929 FLUORIDE VARNISHES, 2,652 CLEANINGS, 2,601 ORAL HEALTH INSTRUCTIONS, 9,758 SEALANTS AND ALL SERVICES PROVIDED ON THE TRUCKS HAD A VALUE OF CARE OF \$2,430,643 FOR WHICH THE DELTA DENTAL FOUNDATION ONLY RECEIVED \$586,626 IN COMPENSATING REVENUE FOR THE ABOVE SERVICES.

THERE WERE 3,452 FLUORIDE VARNISHES APPLIED, 3,250 CLEANINGS PROVIDED, 3,504 PATIENTS GIVEN ORAL HEALTH INSTRUCTIONS, 8,365 SEALANTS PLACED FOR A TOTAL VALUE OF CARE OF \$854,266 FOR WHICH THE DELTA DENTAL FOUNDATION
